SUBORDINATION AGREEMENT

Whereas, the said Party of the Pirst Part is willing to subordinate its said lien and make the second and subservient to the mortgage of the said Part of the Second Part as an inducement to it to make said loan.

Now therefore, in consideration of the premises and further consideration of the sum \$ _0_____, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the Pirst Part does hereby agree that the lien of __DOUGLAS A. MCCULLOUGH AND WIFE. LINDA P.
