KNOW ALL MEN BY THESE PRESENTS, That I, Tomlyn Emfinger Mathews, of Montevallo, Shelby County, Alabama, being over the age of twenty one years, of sound mind and disposing memory, and considering the uncertainty of this life, do hereby make, ordain, publish and declare this to be My Last Will and Testament, hereby revoking all former wills which may have been made at any time by me.

As to my worldly estate and all the Real and Personal or mixed property of which I shall die seized and possessed, and to which I shall be entitled at the time of my death, I devise, bequeath and dispose thereof in the following manner, to wit:

FIRST: My will is that my debts and funeral expenses shall, by my Executrix hereinafter named, be paid out of my estate as soon after my decease as is convenient.

SECOND: I give, devise and bequeath all of my estate, real, personal, and mixed, including all ready money in the hands of my bank or bankers or in the hands of any of my agents, all articles and monies due me by contract, personal or otherwise, notes, stocks and bonds, mortgages, leases and accounts of which I shall die seized and possessed, or to which I shall be entitled at the time of decease, wherever situated, to my two beloved sons, Lynford Thomas Emfinger and Jimmie Lee Emfinger, to be theirs absolutely, Except, I give to my beloved stepson, Walter C. Mathews, any money that he may owe me at my death, and if I still own the 1959 Cadillac, I leave this Cadillac to Walter C. Mathews, and I also leave \$3,000.00 and two bedroom suites from my business, to Walter C. Mathews.

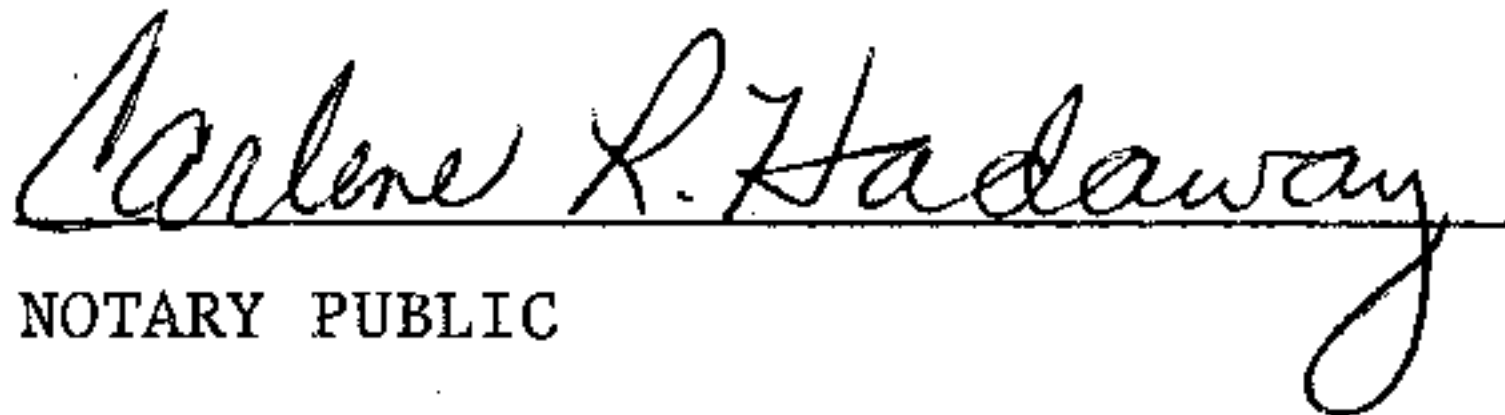
