SUBORDINATION AGREEMENT

THIS SUBORDINATION OF MORTGAGE executed this // day of June, 1993, by First Alabama Bank (hereinafter referred to as the "Mortgagee").

WITNESSETH:

WHEREAS, Mortgagee is the owner and holder of that certain second mortgage (with a maximum line of \$90,000.00 available to draw) from Rowell S.
