CERTIFICATE OF FOURTH AMENDMENT
TO
AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP
OF
CSR, LTD.

Pursuant to Ala Code § 10-9A-21 the undersigned general and limited partners of CSR, Ltd. (the "Partnership"), an Alabama limited partnership organized and existing pursuant to an Agreement and Certificate of Limited Partnership (the "Partnership Agreement") recorded in Book 29, Page 891, in the Office of the Judge of Probate of Shelby County, Alabama, as amended by Certificate of First Amendment, Certificate of Second Amendment and Certificate of Third Amendment recorded in Book 044, Page 35, Book 045, Page 489, and Instrument Number 1992-5828, respectively, in said office, do hereby certify and agree to the following additional amendment to the Partnership Agreement:

ARTICLE I

The name of the Partnership is: **CSR, LTD.**

ARTICLE II

The date of filing of the Partnership Agreement was March 11, 1986, the Certificate of First Amendment thereto was filed on April 22, 1991, the Certificate of Second Amendment was filed on November 4, 1991, and the Certificate of Third Amendment was filed on April 25, 1992.

ARTICLE III

The 20% general partnership interest and the 5% limited partnership interest in the Partnership heretofore owned by A. T. Scott was purchased and redeemed by the Partnership, and thus A. T. Scott withdrew as a general and limited partner, effective October 1, 1992. Accordingly, Article VI of the Partnership Agreement is hereby amended effective as of October

1, 1992, to read as follows:

VI. Interest of the Partners in the Partnership. The Partner's respective percentage interests in the Partnership are as follows:
