# A NONPROFIT CORPORATION

These articles of incorporation are signed and acknowledged by the incorporators for the purpose of forming a nonprofit corporation under the provisions of the Code of Alabama, 1975, known as the Alabama Nonprofit Corporation Act, as follows:

#### ARTICLE I: NAME

The name of the Corporation shall be "Cahaba Valley Lodge, No. 1738, Benevolent and Protective Order of Elks of the United States of America."

## ARTICLE II: OBJECTS

The objects or purposes of the Corporation are as follows:

(a) To foster, develop and promote the principals of Charity, Justice, Brotherly Love and Fidelity; to promote the welfare and enhance the happiness of its members; to quicken the spirit of American patriotism; to cultivate good fellowship and to inperpetuate itself as a fraternal organization.

(b) To do all things necessary and incident to promote the general social, benevolent and charitable works of the corporation in the State of Alabama.

# ARTICLE III: POWERS

- (1) The Corporation shall have all the general powers enumerated in the Code of Alabama, 1975, § 10-3A-1 et seq.
- (2) To receive and administer funds for the aforesaid purposes, and for no other purpose, and to that end to take and hold by contract, agreement, bequest, devise, gift, purchase, lease, either absolutely or in trust for such objects and purposes or trust and by membership fees received and contracts entered into for its purposes as herein stated and for no other purpose.

# ARTICLE V: MEMBERSHIP

# ARTICLE VI: OFFICERS, DIRECTORS AND TRUSTEES

- (a) The Officers, Directors and Trustees of the Corporation, their nominations, election or appointment, installation power and authority shall be in accordance with the provisions of the By-Laws of the Corporation.
- (b) The governing body of the Corporation shall be its Board of Directors, which said Board of Directors shall consist of all of the following: the Officers of the Corporation, who are entitled EXALTED RULER (President), ESTEEMED LEADING KNIGHT (Executive Vice President), ESTEEMED LOYAL KNIGHT (First Vice President), ESTEEMED LECTURING KNIGHT (Second Vice President), and five persons who shall bear the title of Trustee.

# ARTICLE VII: BY-LAWS

The Board of Directors shall adopt By-Laws for the governance of the Corporation.

# ARTICLE VIII: REGISTERED OFFICE AND REGISTERED AGENT

The location and address of the Corporation registered office is 1738 Morgan Park Drive in the City of Pelham, Alabama. The post office address of Palmer Maxwell, registered agent, is 1738 Morgan Park Drive in the City of Pelham, Alabama.

#### ARTICLE IX: AUTHORITY

The Corporation is organized on a nonstock basis. The Corporation is to be financed under the following general plan: by contributions to it of

funds and property absolutely or in any of them, any property real, personal or mixed, without limitations as to amount or value, except such limitation, if any, as may be imposed by law; to sell, convey, and dispose of any such property and to deal with such property for any of the aforementioned purposes without limitation, except such limitations, if any, may be contained in the instrument under which such property is received; and to exercise any, all, and every power for which a nonprofit corporation organized the provisions of the Alabama Nonprofit Corporation Act, all for the public welfare can be authorized to exercise, but not any other power. No part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation.

## ARTICLE X: DURATION

This being a benevolent corporation, its term is unlimited and in perpetuity.

## ARTICLE XI: DISSOLUTION

All property of the Corporation and accumulations thereof shall be held and administered to effectuate its purposes and to serve the general welfare of the people of the State of Alabama. Upon the dissolution of this nonprofit Corporation for any cause, the assets of the Corporation of whatever kind and wherever situated shall be transferred in total to the

Alabama Elks Foundation, Incorporated. No distribution of the assets of the Corporation shall ever be made to any member, director, Trustee or Officer of the Corporation.


