## AMENDMENT TO MORTGAGE

THIS AMENDMENT amends that certain Mortgage and Security Agreement (hereinafter "Mortgage") executed on October 20, 1992 by BROOK HILLS BAPTIST CHURCH, INC. (hereinafter "Borrower") in favor of COLONIAL BANK (hereinafter "Bank").

- 1). Henceforth the Mortgage shall specifically secure not only the \$2,500,000.00 Note executed in connection therewith, and all renewals and extensions thereof, but also an additional advance or loan of \$200,000.00 made in connection herewith to Borrower, and all the interest thereon.
- 2). The term "Loan" and "Note" as used in the Mortgage shall be defined to mean not only the Loan evidenced by the \$2,500,000.00 Note executed on October 20, 1992, and all interest thereon, and all extensions and renewals thereof, but also the \$200,000.00 advance or loan being made in connection herewish, talk 31191118666 thereon, and
