SUBORDINATION AGREEMENT

This Subordination Agreement, made and entered into on this the ____ day of <u>July</u>, 1993, by and between <u>FIRST ALABAMA BANK</u>

WITNESSETH

Whereas, <u>Jeffrey Kent Johnson and April Hammond Johnson</u> have made an application to the Party of the Second Part for a loan in the sum of \$ 56,250.00 and said Party of the Second Part is willing to make said loan to the said <u>Jeffrey Kent Johnson and April Hammond Johnson</u> provided they furnish it with a mortgage on the lands described in the aforesaid lien, and the said <u>FIRST ALABAMA BANK</u> subordinate the above described lien and make the same second and subservient to the mortgage of <u>SOUTHTRUST MORTGAGE CORPORATION</u>; and

Whereas, the said Party of the First Part is willing to subordinate its said lien and make the second and subservient to the mortgage of the said Part of the Second Part as an inducement to it to make said loan.

Now therefore, in consideration of the premises and further consideration of the sum \$ -0-, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of _Jeffrey Kent Johnson and April Hammond Johnson to _FIRST ALABAMA BANK _, dated _5-29-92 and recorded in the Probate Office of _Shelby County, Alabama in Official Instrument No. __1992-10114 _, shall be second and subservient to the mortgage of _Jeffrey Kent Johnson and April Hammond Johnson to _SOUTHTRUST MORTGAGE CORPORATION _, dated _July 23, 1993 and recorded in the Probate Office of _Shelby County, Alabama in Official Instrument No. ________, to secure the sum of \$ 56,250.00 plus interest, on the land described therein, and the said lien of the said _FIRST ALABAMA BANK _ shall be subordinate to the mortgage of _SOUTHTRUST MORTGAGE CORPORATION.

JEFF K. JOHNSON AND JEFFREY KENT JOHNSON ARE ONE AND THE SAME PERSON; APRIL H. JOHNSON AND APRIL HAMMOND JOHNSON ARE ONE AND THE SAME PERSON.

It is further agreed that should <u>Jeffrey Kent Johnson and April Hammond Johnson</u> default in their payments under the terms of the real estate mortgage to <u>SOUTHTRUST MORTGAGE CORPORATION</u>, the said <u>SOUTHTRUST MORTGAGE CORPORATION</u> agrees to notify <u>FIRST ALABAMA BANK</u> of said default prior to taking legal action.
