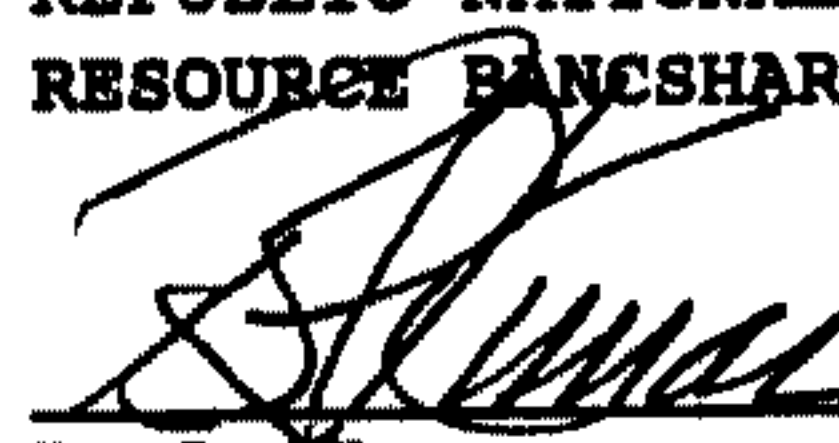
ASSIGNMENT OF MORTGAGE
