

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS That for and in consideration of Five Thousand (\$5,000.00) Dollars and other good and valuable consideration to the undersigned grantors, Frances L. Swann, Malcolm L. Jones, Richard W. Jones, Betty Morris, Madalyn Mitchell, Charles R. Jones and Bobby E. Jones, in hand paid by the grantee, Madalyn Mitchell, the receipt whereof is acknowledged, the said above-named grantors do grant, bargain, sell and convey unto the said Madalyn Mitchell the following described real estate, to-wit:

One lot on the East side of North Main Street in the Town of Columbiana, Alabama, described as follows: Beginning at the Southwest corner of what was formerly known as the Mrs. Jennie Sheffell's lot, now known as the Emmie R. Young residence lot, and running thence in an Easterly direction with the South line of the said Jennie Sheffell lot now known as the Emmie F. Young lot to the lands formerly owned by Bird Teague, and now known as the H. L. Gould lot; run thence in a Southerly direction with the H. L.
