

ARTICLES OF INCORPORATION OF
ALABAMA SILVER RECOVERY, INC.

The undersigned natural persons, each over the age of nineteen years, hereby establish a corporation pursuant to the statutes of the State of Alabama, and adopt the following articles of incorporation:

ARTICLE ONE

Name. The name of the corporation is ALABAMA SILVER RECOVERY INC.

ARTICLE TWO

Duration. The corporation shall have perpetual existence.

ARTICLE THREE

Purpose and Powers.

(a) The corporation is organized for the purpose of the recovery of silver through the reprocessing of chemicals used in various photographic procedures.

(b) Any and all other businesses or activities in which corporations are allowed to engage under Alabama law, and which are not prohibited by these articles of incorporation or the bylaws.

ARTICLE FOUR

Authorized shares. The aggregate number of shares that the corporation has authority to issue is 100 shares, all of which shall be common shares with par value of \$10.00 per share.

ARTICLE FIVE

Initial Shareholders. The initial shareholders of the corporation are as follows:

ARTICLE SIX

Voting. Each shareholder of record shall have one vote for each share of stock standing in his name on the books of the corporation. Cumulative voting for the election of directors is not permitted.
