That in consideration of SEVENTY SEVEN THOUSAND NINE HUNDRED & NO/100---- (\$77,900.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Walter J. McNish and wife, Hazel k. McNish (herein referred to as grantors), do grant, bargain, sell and convey unto Charles David Hill and Sherri Cain, single individuals (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:


