TO HAVE AND TO HOLD unto the said GRANTEE as his/her heirs and assigns, forever.

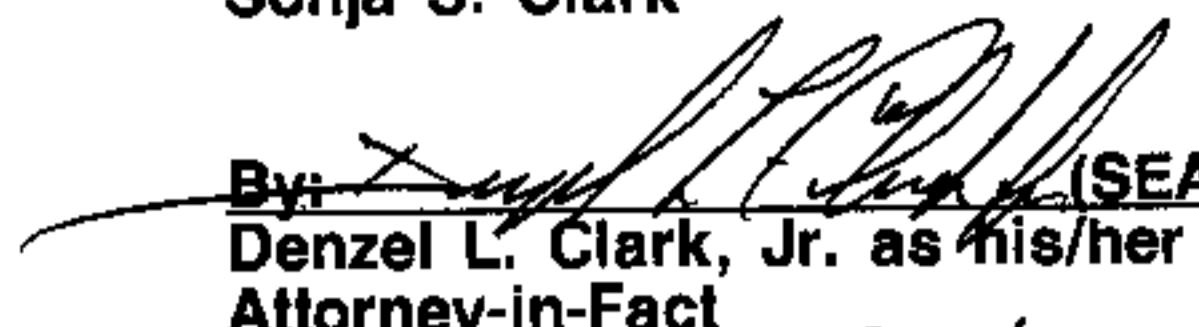

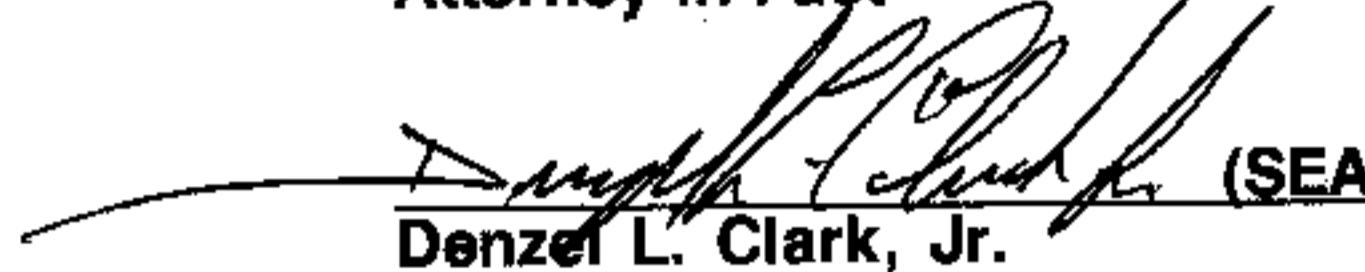

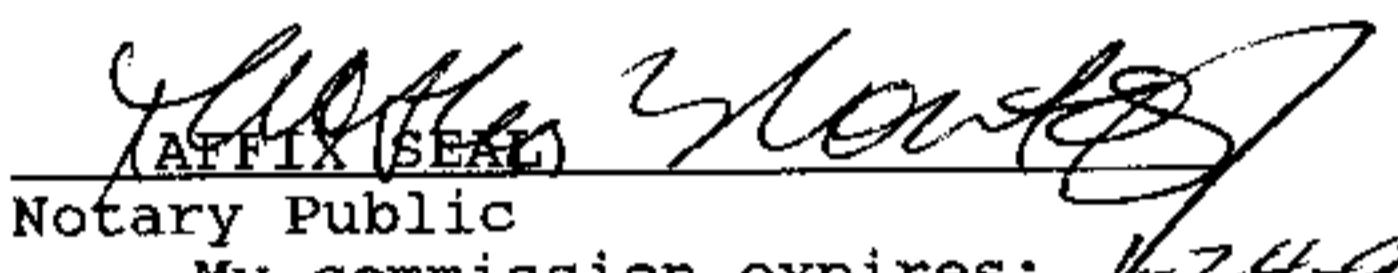
