

## EXHIBIT "A" LEGAL DESCRIPTION

Part of the NW 1/4 of the SW 1/4 of Section 20, Township 20 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows:

Beginning at a point of intersection of the East line of said 1/4-1/4 Section with the NW right of way line of Shelby County Highway #332 (said point being 25 feet at a right angle to the centerline of said Highway #332), run in a northerly direction along the East line of said 1/4-1/4 Section for a distance of 478.61 feet to an existing bolt; thence turn an angle to the left of 87 degrees 32 minutes 39 seconds and run in a westerly direction for a distance of 463.64 feet to an existing old open top iron pin; thence turn an angle to the left of 82 degrees 16 minutes 36 seconds and run in a southwesterly direction for a distance of 409.94 feet to an existing bolt; thence turn an angle to the left and run in an easterly direction along the Northerly right of way line of the existing Shelby County Highway #332 for a distance of 580.00 feet, more or less, to the point of beginning.
