

CORPORATION WARRANTY DEED

(hereinafter "GRANTOR") a corporation, in hand paid by the grantees herein, the receipt whereof is acknowledged, grantor, a corporation, does grant, bargain, sell and convey unto JOHN W. BROCK and CATHY D. BROCK (hereinafter "GRANTEES"), all of its interest in the following described real estate, situated in Jefferson County, Alabama:

Lot 64, according to the Map and Survey of King's Crest Sector 3, Phase 2 as recorded in Map Book 16 page 141 in the Office of the Judge of Probate of Shelby County, Alabama.

Mineral and mining rights are not warranted. Subject to any and all other matters of public record including but not limited to any and all restrictions and covenants of record.

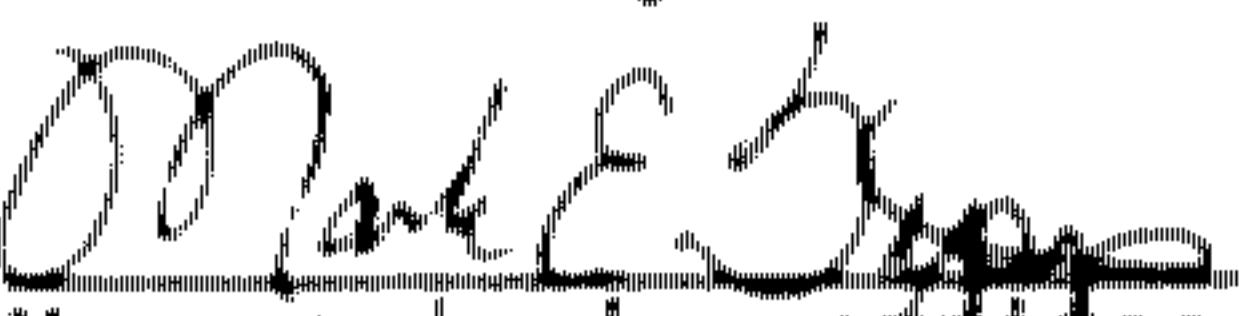
