SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF SHELBY

This Subordination Agreement, made and entered into on this the 26th day of August, 1993, by and between AMSOUTH BANK, N.A., as Party of the First Part, and REAL ESTATE FINANCING, INC., as Party of the Second Part.

WITNESSETH
