by, through, or under Grantor.

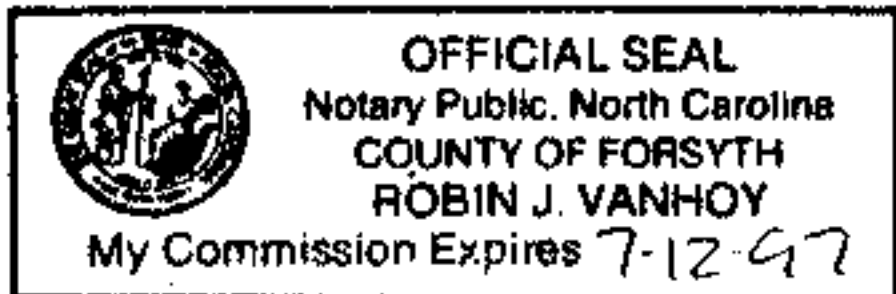
