FULL RELEASE OF LIEN AND PRO TANTO RELEASE
OF MONETARY CLAIMS

TAKE NOTICE that Clint Hurt & Associates, Inc., lien claimant under that certain Notice of Lien recorded at Instrument No. 1992-17534 in the books and records of Shelby County, does hereby fully, finally and forever release and relinquish all liens and claims of lien as to all parties and property covered thereby. Further, Clint Hurt & Associates, Inc. has dismissed with prejudice all parties except McKenzie Methane Corporation (and any present or former officers, directors, shareholders, employees, agents, or representatives of McKenzie Methane Corporation other than S. Lanham Frazier, III and Al Haertlein) from its action to enforce said liens, being Case No. CV-92-770, previously pending in the Circuit Court for said County and State.

Further, Clint Hurt & Associates, Inc. hereby releases and relinquishes all monetary claims asserted by Clint Hurt & Associates, Inc. against Smith-Gordy Methane Company, SG Methane Company, KUKUI, INC., The Northwestern Mutual Life Insurance Company, JGI Resources, Inc., Mission Energy Methane Company, Bank of Montreal, USX Corporation, Southern Electric Generating Company, Kimberly Clark Corporation, Robert W. Poellnitz, S. Lanham Frazier, III, and Al Haertlein in *Clint Hurt & Associates, Inc. v. McKenzie Methane Corporation, et al.*, Cause No. 92-69, Bibb County, Alabama, Cause No. 92-770, Shelby County, Alabama, and Cause No. 92-1337, Tuscaloosa County, Alabama, pending in the Circuit Courts of said Counties (the "Hurt Suits"), and in the Cross-Claim (the "Hurt Cross-Claim") filed by Clint Hurt & Associates, Inc. in *SONAT Marketing Company, Interpleader*, Case No. A.P. 92-00503, pending as an adversary proceeding in the United States Bankruptcy Court for the Northern District of Alabama Southern Division in connection with Case No. 92-05759, Pilgreen Producing Company, Debtor, in said Court; provided that this is a pro tanto release of the monetary claims asserted in the Hurt Suits and Hurt Cross-Claim and that Clint Hurt & Associates, Inc. does not hereby release any monetary claims of Clint Hurt & Associates, Inc. against McKenzie Methane Corporation or Pilgreen Producing Company or any of their respective present or former officers, directors, shareholders, employees, agents, or representatives other than S. Lanham Frazier, III and Al Haertlein, and said claims are hereby expressly preserved, even though the release of liens and claims of liens hereinabove set forth does fully and finally release all liens and claims of liens of Clint Hurt & Associates, Inc. as against all interests of McKenzie Methane Corporation and all other owners of interests in all property described in or affected by the above referenced Notice of Lien.

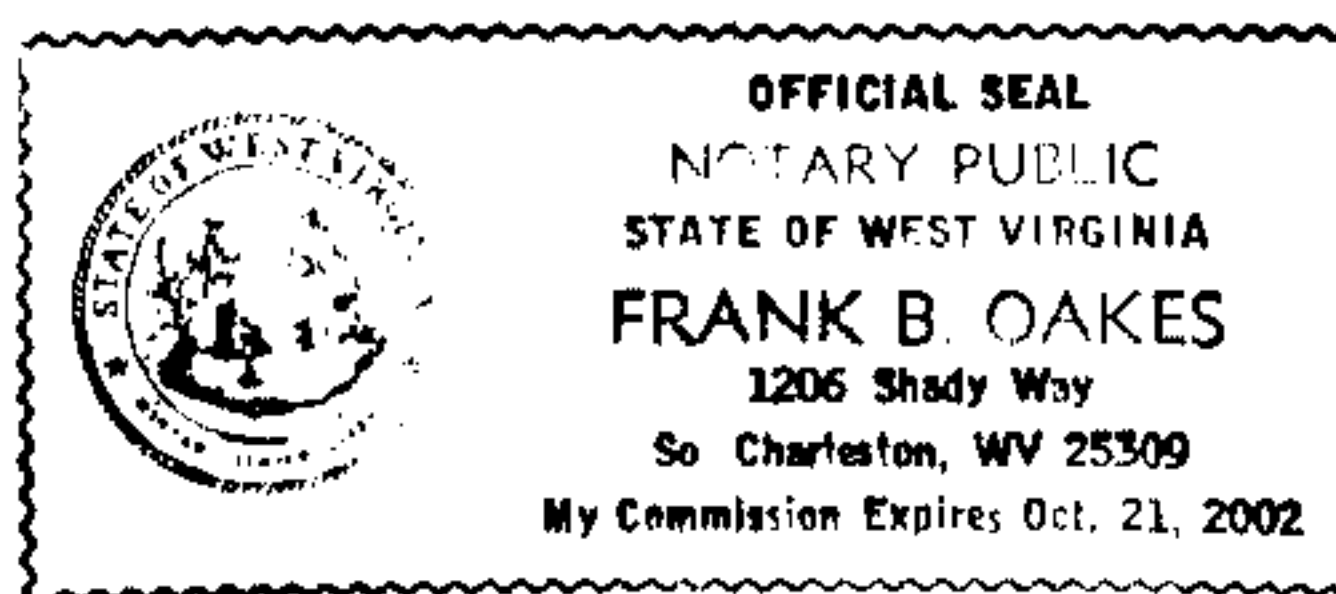
