**FULL RELEASE OF LIEN AND PRO TANTO RELEASE
OF MONETARY CLAIMS**

TAKE NOTICE that Consolidated Pipe & Supply Co., Inc., lien claimant under that certain Notice of Lien recorded at Instrument Number 1992-17120 in the books and records of Shelby County does hereby fully, finally, and forever release and relinquish all liens and claims of lien as to all parties and property covered thereby. Further, Consolidated Pipe & Supply Co., Inc. has dismissed its action to enforce said liens, being Case no. CV-92-755, previously pending in the Circuit Court for said County and State, with prejudice except only that such dismissal is without prejudice solely as to monetary claims (and not lien claims) asserted by Consolidated Pipe & Supply Co., Inc. as against McKenzie Methane Company in said suit.

Cain, Sr., Wilbur G. Belk, et ux., Robert W. Poellnitz, Wilma L. Keeth, Emmett O. Dendy, Earl Winstead, Percy Leonard Spiller, Edward W. Oehmig, Lewis D. Oehmig, Von D. Oehmig, Daniel W. Oehmig, Francis Gertrude Oehmig, Dunbar N. Oehmig, William G. Oehmig, III, William J. Shamblin, Donald E. Rice, William Hinton, George Hinton, S. Lanham Frazier, III, and Al Haertlein in *Consolidated Pipe & Supply Co. v. Pilgreen Producing Company, et al.*, Cases Nos. A.P. 92-00500, A.P. 92-00479, A.P. 92-00512, and A.P. 92-00527 (the "Consolidated Suits"), now pending as adversary proceedings in the United States Bankruptcy Court for the Northern District of Alabama Southern Division in connection with Case No. 92-05759, Pilgreen Producing Company, Debtor, in said Court; provided that this is a pro tanto release of the monetary claims asserted in the Consolidated Suits and that Consolidated Pipe & Supply Co., Inc. does not hereby release any monetary claims of Consolidated Pipe & Supply Co., Inc. against McKenzie Methane Corporation or Pilgreen Producing Company, even though the release of liens and claims of liens hereinabove set forth does fully and finally release all liens and claims of liens of Consolidated Pipe & Supply Co., Inc., as against all interests of McKenzie Methane Corporation and all other owners of interests in all property described in or affected by the above referenced Notice of Lien.
