SHELBY COUNTY) KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One Dollar (\$1.00) and other good and valuable consideration, and execution of Agreement, to the undersigned grantors in hand paid by the GRANTEE herein, the receipt whereof is acknowledge we, William H. Armstrong and wife, Donna Sue Armstrong (herein referred to as grantors) do grant, bargain, sell and convey unto WILLIAM H. ARMSTRONG (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama to-wit:

A parcel of land situated in the S 1/2 of the NE 1/4, Section 15, Township 19 South, Range 1 East, Shelby County, Alabama, being more particularly described as follows:
Commence at the NW corner of the SW 1/4 of the NE 1/4 of said Section 15; thence South 88 deg. East 11.64 chains to a point on the centerline of Shelby County Highway No. 55, which point is the point of beginning and the NW corner of the parcel of land herein described; from the point of beginning thence South 25 deg. West along the center line of said highway 9.98 chains; thence South 88 deg. East 9.65 chains; thence South 48 deg. East 6.16 chains; thence North 58 deg. East 7.11 chains; thence North 2 deg. East 5.97 chains; thence North 88 deg. West 6.59 chains; thence North 2 deg. East 3.03 chains; thence North 88 deg. West 9.46 chains to the point of beginning; LESS AND EXCEPT that portion of the above described parcel lying south of the north side of a road that adjoins the east side of Shelby County Highway No. 55 at a point approximately 5.6 chains south of the Northwest corner of the parcel and meanders in a southeasterly direction; the parcel of land herein conveyed containing 14 acres, more or less.
