THAT IN CONSIDERATION OF One Hundred Sixty Three Thousand One Hundred Dollars and 00/100 (\$163,100.00) to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **A.D. Chandler Co., Inc., an Alabama corporation**, (herein referred to as Grantors, whether one or more) do grant, bargain, sell and convey unto **Curtis Ray Wilson and wife, Donna S. Wilson** (herein referred to as Grantees, whether one or more) as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:
