SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF JEFFERSON

This Subordination Agreement, made and entered into on this the 29th day of April , 1993, by and between AMSOUTH BANK, N.A. , as Party of the First Part, and FIRST FEDERAL BANK, A Federal Savings Bank, as Party of the Second Part.

WITNESSETH

That, whereas, <u>Geoffrey Howard Parker and wife, Katherine</u> Ann Parker and William M. Whereas, the said Party of the First Part is willing to subordinate its said lien and make the second and subservient to the mortgage of the said Part of the Second Part as an inducement to it to make said loan.

Now therefore, in consideration of the premises and further consideration of the sum $\frac{5}{-0-}$, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of Geoffrey Howard Parker and Katherine Ann Parker, husband and wife, to AMSOUTH BANK, N.A., dated 12/4/91 and recorded in the Probate Office of __SHELBY_ County, Alabama, in Official Record Book 378 Page 856, shall be second and subservient to the mortgage of <u>Geoffrey Howard Parker and</u> Katherine Ann Parker, husband and wife to FIRST FEDERAL BANK, A Federal Savings Bank, dated April 29, 1993 and recorded in the Probate Office of SHELBY County, Alabama, in Official Record Book <u>1993</u>, Page <u>13530</u>, to secure the sum of \$ <u>134,900.00</u> plus interest, on the land described therein, and the said lien of the said AMSOUTH BANK, N.A. shall be subordinate to the mortgage of FIRST FEDERAL BANK, A Federal Savings Bank .
