- I, the undersigned President of the South Shelby Chamber of Commerce, an unincorporated association that for some time has acted to promote business, commerce and industry in South Shelby County, Alabama, having previously been authorized to do so by a majority vote of said unincorporated association, hereby sign, verify and file the following articles of incorporation, under the Alabama Non-Profit Corporation Act, SEC.10-3A-1 to 10-3A-225 of the 1975 Alabama Code, as amended:
- (1) The name of the corporation shall be: The South Shelby Chamber of Commerce, Inc.
- (2) The period of duration of the corporation shall be perpetual.
- (3) The purpose for which the corporation is organized shall be to promote business, commerce and industry in South Shelby County, Alabama. The corporation shall be authorized to do anything consistent with its status as a non profit corporation in pursuit of that goal, including sponsoring parades, arranging for the erection and illumination of street decorations for Christmas or otherwise, holding banquets, barbecues, contests, sales, seminars and training sessions, issuing public statements, printing and distributing brochures, coupons, directories and other publications, participating in local celebrations and other programs,

working with area youth in sales, and informing the public of the advantages associated with living and working in South Shelby County.

- (4) The corporation shall have one class of members, who shall meet the qualifications set out in the bylaws. No member shall profit or otherwise derive pecuniary gain from his, her or its membership.
- (5) The directors shall be elected by the members in accordance with the bylaws.
- (6) The internal affairs of the corporation shall be regulated by the bylaws, consistently with applicable law and these articles. In the event of inconsistency, the law shall be controlling. In the event of inconsistency between these articles and the bylaws only, these articles shall be controlling, except that an amendment to the bylaws may change the number of directors of the corporation.


