ORDER AND DECREE OF CONDEMNATION

- 3. All costs to date shall be taxed against the Plaintiff, the State of Alabama.
- 4. That the parties having a right, title and interest in and to said property are Darryl Ann Schilli, Trustee for David M. Schilli and Robert B. Schilli, Jr., DAS Properties, Inc. Material Delivery Service, Inc. and Annette Skinner, Tax Collector for Shelby County, Alabama.

It is therefore, CONSIDERED, ORDERED, ADJUDGED, AND DECREED by the Court, that the application for Order of Condemnation of the hereinafter described lands, be and the same is hereby granted and allowed.

It is further ORDERED, ADJUDGED, AND DECREED by the Court that, pursuant to the stipulation of the parties, the damages and just compensation to which the several Defendants are entitled in this cause, is the sum of One Thousand Five Hundred Dollars (\$1,500.00). The Clerk of the Court is hereby authorized and directed to pay to the Defendants the sum One Thousand Five Hundred Dollars (\$1,500.00), which is the amount of the final award in this cause.

It is further ORDERED, ADJUDGED, AND DECREED by the Court that the Plaintiff, the State of Alabama, be and is hereby given and awarded and there is hereby transferred and conveyed to the Plaintiff, the State of Alabama, in fee, the hereinafter described lands, for the uses and purposes sought in the application of condemnation as hereinafter described as follows:


