KNOW ALL MEN BY THESE PRESENTS, that in consideration of ONE HUNDRED EIGHTY FOUR THOUSAND & NO/100 (\$184,000.00) to the undersigned grantors W. Mark Daniel and wife, Pamela G. Daniel in hand paid by R. Keith King and Debra Y. King, the receipt whereof is acknowledged, we, W. Mark Daniel and wife, Pamela G. Daniel (herein referred to as Grantors) grant, bargain, sell and convey unto R. Keith King and Debra Y. King (herein referred to as Grantees), as joint tenants, with right of survivorship, the following real estate, situated in Shelby County, Alabama, to wit:


Subject to existing easements, restrictions, building set-back lines, rights of way, limitations, if any, of record.


