The following amendment was adopted in the manner provided by the Alabama Non-profit Corporation Act:

NAME changed to First Baptist Church Helena

Article III

A meeting of the members entitled to vote on such amendment was held on August 22, 19 93, a quorum was present at such meeting and the amendment received at least two-thirds of the votes entitled to be cast by members present or represented by proxy. If no meeting was held, then a statement that such amendment was adopted by a consent in writing signed by all members entitled to vote.

Article IV

If there are no members, or no members entitled to vote thereon, a statement of such fact, the date of the meeting of the Board of Directors at which the amendment was adopted and a statement of the fact that such amendment received the vote of a majority of the Directors in office.
