SUBORDINATION AGREEMENT

WHEREAS, Borrower has requested that AmSouth lend to it the sum of \$\frac{181.500.00}{181.500.00}\$ (the "Loan"), such loan to be evidenced by a promissory note dated October 25 , 1993 , executed by Borrower in favor of AmSouth and secured by a mortgage of even date therewith (the "New Mortgage") covering in whole or in part the property covered by the Mortgage; and
