I, Robert Eugene Sult, being of sound mind, of lawful age and competent to testify, hereby state and attest upon my caun personal knowledge the following facts pertaining to varios alleged "Federal Tax Liens" and/or "assessments" currently being asserted by the Internal Revenue Service (an agency of the District of Columbia) against myself and my property. The following statement of facts constitutes my afffirmed testimony against all documents entitled "NOTICE OF FEDERAL TAX LIEN UNDER INTERNAL REVENUE LAW," filed for record with the Shelby County clerk's office in Columbiana. Alabama and bearing the name Robert E. Sult:

1. I am the natural individual making this affirmation as evidenced by my subscribed signature and common law seal (my right thumb print) affixed hereto. I am acting sui juris in this instant affidavit; and,

STATEMENT OF CAUSE

- 2. The above stated documents, each entitled "NOTICE OF FEDERAL TAX LIEN," are not provided for by sections 6321, 6322 and 6323 of the Internal Revenue Code. Notice is hereby given that the alleged taxes (as well as interest and penalties) have not been legitimately assessed against myself. No legitimate demand for payment of the purported liability has ever been made and it requires no payment. Therefore, there are no liens in favor of the United States on any property or rights to property belonging to myself for the purported taxes. Neither are any additional penalties, interest and costs owed as alleged in the aforesaid documents, each entitled "NOTICE OF FEDERAL TAX LIEN," and,
- 3. I am not a citizen, inhabitant, subject, or resident of the District of Columbiana, its territories, or its political subdivisions and/or other affiliates; or of any property subject to the jurisdiction thereof. I do not reside or have property within any legislative district of the District of Columbia, any subordinate territories thereof, or geographical area appertaining thereto, in either a legal or factual sense. I am not now, nor have I ever been "person born or naturalized in the United States and subject to the juisdiction thereof." It is understood that the term "United States" as used in the 14th Amendment means the District of Columbia; and,
- 4. I am of the white race and am a natural Citizen of the Sovereign Body as known to and contemplated by the Preamble to the Constitution for the united States of America, its succeeding original Articles 1 thru VII (1787) and its succeeding Bill of Rights, Articles 1 thru X (1791); and also as known to the original (1819) and its respective succeeding articles; and,
- 5. I possess and hold my property under the protection of the general limitations upon the united States of America declared in the original Constitution (1787) and its Bill of Rights (1791) and as further specifically declared in the Fourth Article in Amendment thereto:

"The rights of the People to be secure in their persons, houses, papers and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by Cath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

and under the general limitations upon the State of Alabama which were declared in the original Constitution of Alabama (1819), and as specifically delineated in (Article 1, Section 7), thereof:

"The People shall be secure in their persons, houses, papers, and possessions, from all unreasonable seizures or searches, and no warrant to search any place, or to seize any person or thing, shall issue, without describing them near as may be; nor without probable cause supported by oath or affirmation;" and,

- 6. I, Robert Eugene Sult, am the owner of all my property, real and personal, under the common law. Said property is not located within any legislative district of the District of Columbia (as designated by a zip code) nor is it within any territory or property subject to the jurisdiction of the Congress of the United States pursuant to Article 1, Section 8, Clause 17, of the Original Constitution (1787) or as purportedly expanded by the alleged 14th Amendment. My permanent place of abode is not a "residence" within the meaning and identification asserted by the use of that term in the aforesaid several documents, each entitled "NOTICE OF FEDERAL TAX LIEN," and,
- 7. I do not now, nor have ever had, a Social Security Account Number and I have never given assent thereto or to the implied contract of social insurance and power of attorney embodied therein. The identifying number of 229-70-4471 used on the aforesaid documents, each entitled "NOTICE OF FEDERAL TAX LIEN;" ARE FRAUDS, INVALID AND VOID. So too is the account which that number is intended to represent; and,
- 8. I am not among those designated as "taxpayers" in the Internal Revenue Code. I am not a "taxpayer" within the meaning asserted by the use of that term in the aforesaid several documents, each entitled "NOTICE OF FEDERAL TAX LIEN." There is no legitimate "Tax Period" with respect to Robert E. Sult within the meaning asserted by the use of that term in those documents. Again, all such documents filed with the clerk of Shelby County purporting to be Notices of Federal Tax Liens against me, are fradulent; and.
- 9. I deny that I am now, or have ever been a merchant at law and subject to the Alabama Business Code. I deny that I am now, or have ever been, a voluntary user of District script, id est, Federal Reserve Notes; and,
- 10. I deny that any liability whatsoever for Federal Taxes exists now, or has ever existed, on my part. I deny that I am among those liable for taxes assessed pursuant to the Alabama Business and Commerce Code and under the purported authority of the 13th, 14th and subsequent Amendments and the statutory fiction of the Social Security Act (1935).
- 11. THEREFORE: Let it be known and published that all such Notices of Federal Tax Liens are invalid, void and nullities and are, in fact, instruments of fraud upon their face. Let it be known and published that the sole purpose of the said instruments is to establish a fictitious record in order to justify a later proceeding in a foreign and alien statutory jurisdiction which

was unknown to American jurisprudence prior to the 13th and 14th Amendments, Let it be known and published that such proceedings amount to nothing more dignified and authoritative than the exercise of legal fictions intended for no other purpose than the theft and plunder of property and rights to property; and,

INTENT

- 12. WHEREFORE: This Affidavit is acknowledged, filed and recorded the purpose of purging the public record of the lies and false presumptions against myself placed there by the Internal Revenue Service for the purpose of defrauding same. This Affidavit is intended to dispel and abrogate the contrived and fictitious assertions of the said agency of the District of Columbia couched within the said Notices of Federal Tax Liens. This Affidavit is exweuted for the purpose of protecting the standing of me and mine at common law and the natural rights inherent in that status; said natural rights being superior to the legislative power and beyond reach of that power to destroy them; and,
- 13. The statements and information contained herein are true, is submitted in good faith, for the cause of inducement of fraud perpetuated upon Robert Eugene Sult, and correct to the best of my knowledge; are set forth for cause and in the interests of justice; and are intended to supersede all previous demials of the aforementioned to date previous demials of the aforementioned to date. The signature hereon is the voluntary act of my own hand.
