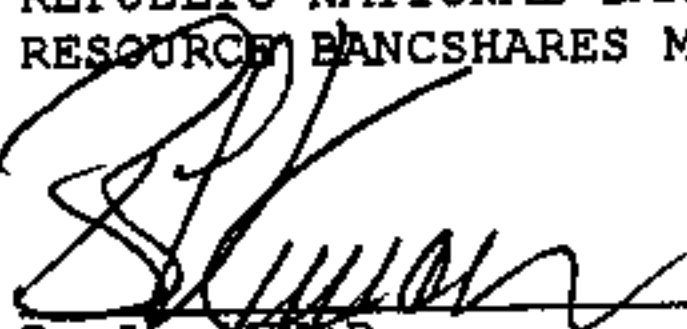

ASSIGNMENT OF MORTGAGE

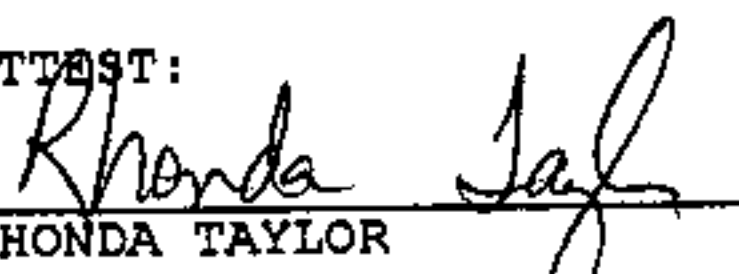

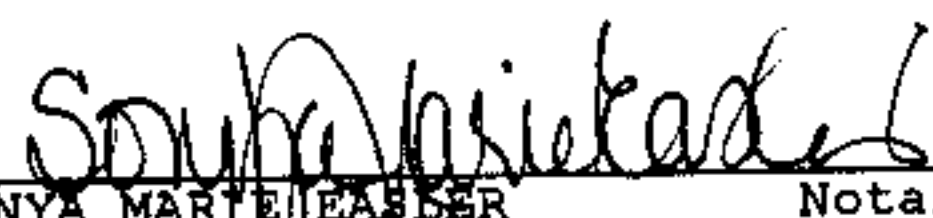

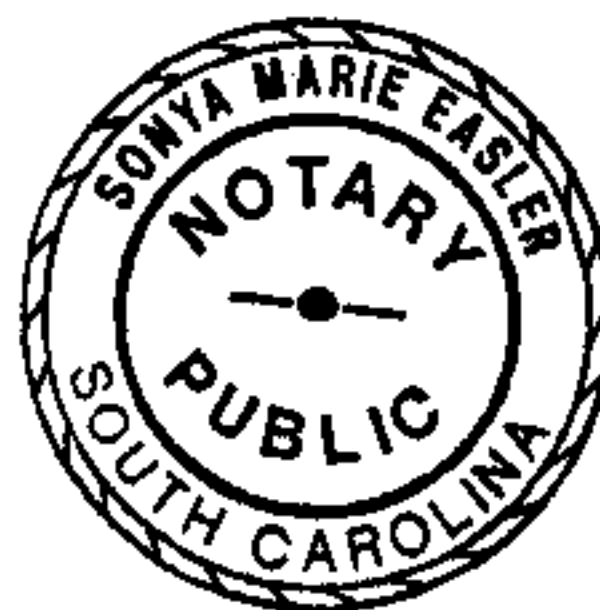
