ASSIGNMENT OF MORTGAGE





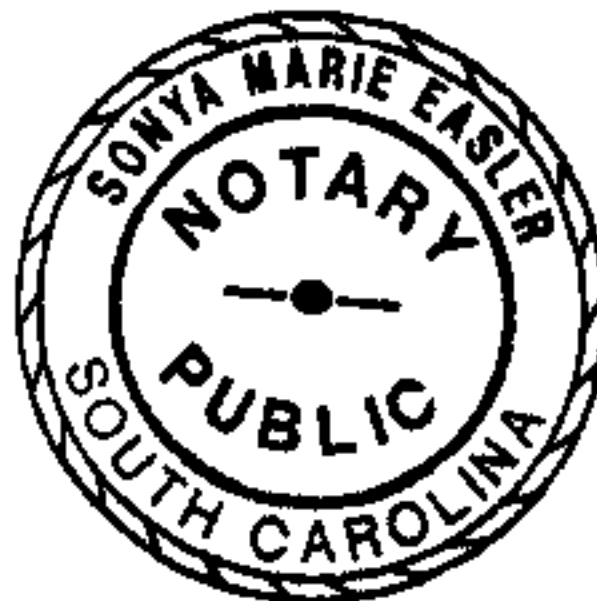
