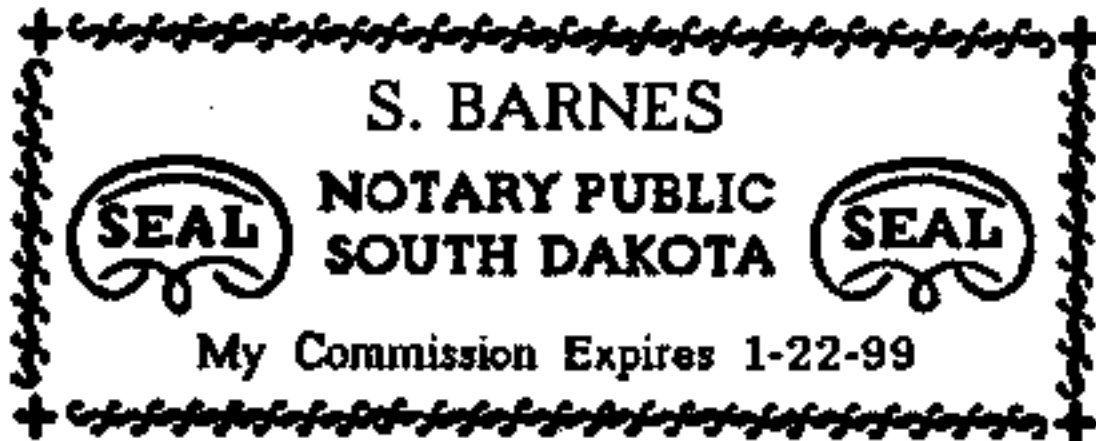

## POWER OF ATTORNEY

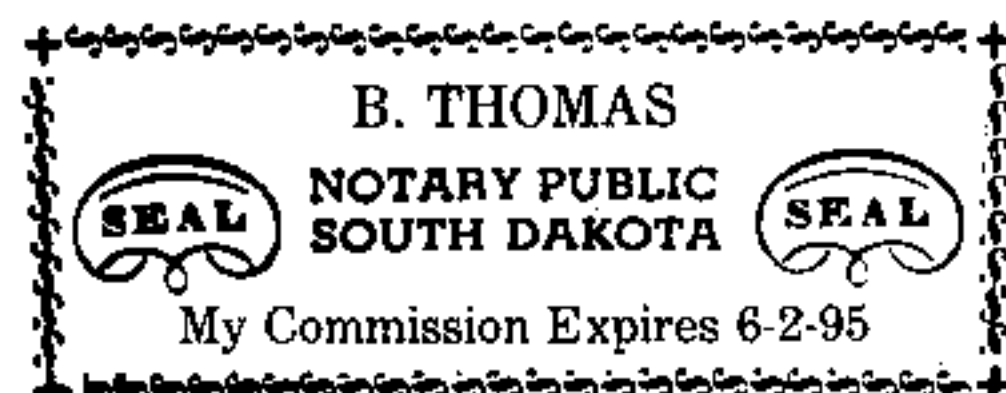
