**RE: KIMBERLY-CLARK CORPORATION - 1993-1994 HUNTING LEASE
AGREEMENT (the "Agreement") WITH YELLOWLEAF
GAME PRESERVE, INC. (the "Preserve")**

In accordance with Paragraph 2.02 of the above Agreement, we are advising you that Kimberly-Clark Corporation has agreed to sell the portion of the lands covered by the Agreement as is described below with the closing to occur on December 16, 1993:

- a) all of Section 28, except the NW1/4 of NW1/4;
- b) the NE1/4 of NE1/4 of Section 32;
- c) the N1/4 of Section 33;

all in Township 20 South, Range 2 West, Shelby County, Alabama and containing 800 acres.

Therefore, you are hereby notified that effective December 16, 1993, the above Agreement, to the extent of the 800 acres described just above, is cancelled. The Agreement will remain in full force and effect, until further notification, with regard to the remaining acreage.

After this sale by Kimberly-Clark Corporation has been completed, you shall be refunded, with regard to the 800 acres, seven (7) months rent as specified in Agreement Paragraph 9.02. If for any reason the proposed sale is not eventually finalized, the 800 acres will be restored to the Agreement.

If the Preserve has any gates on the 800 acres, Kimberly-Clark Corporation would appreciate very much the Preserve removing such gates prior to December 16, 1993.

Enclosed for your reference is a map of the area being deleted from the Agreement.

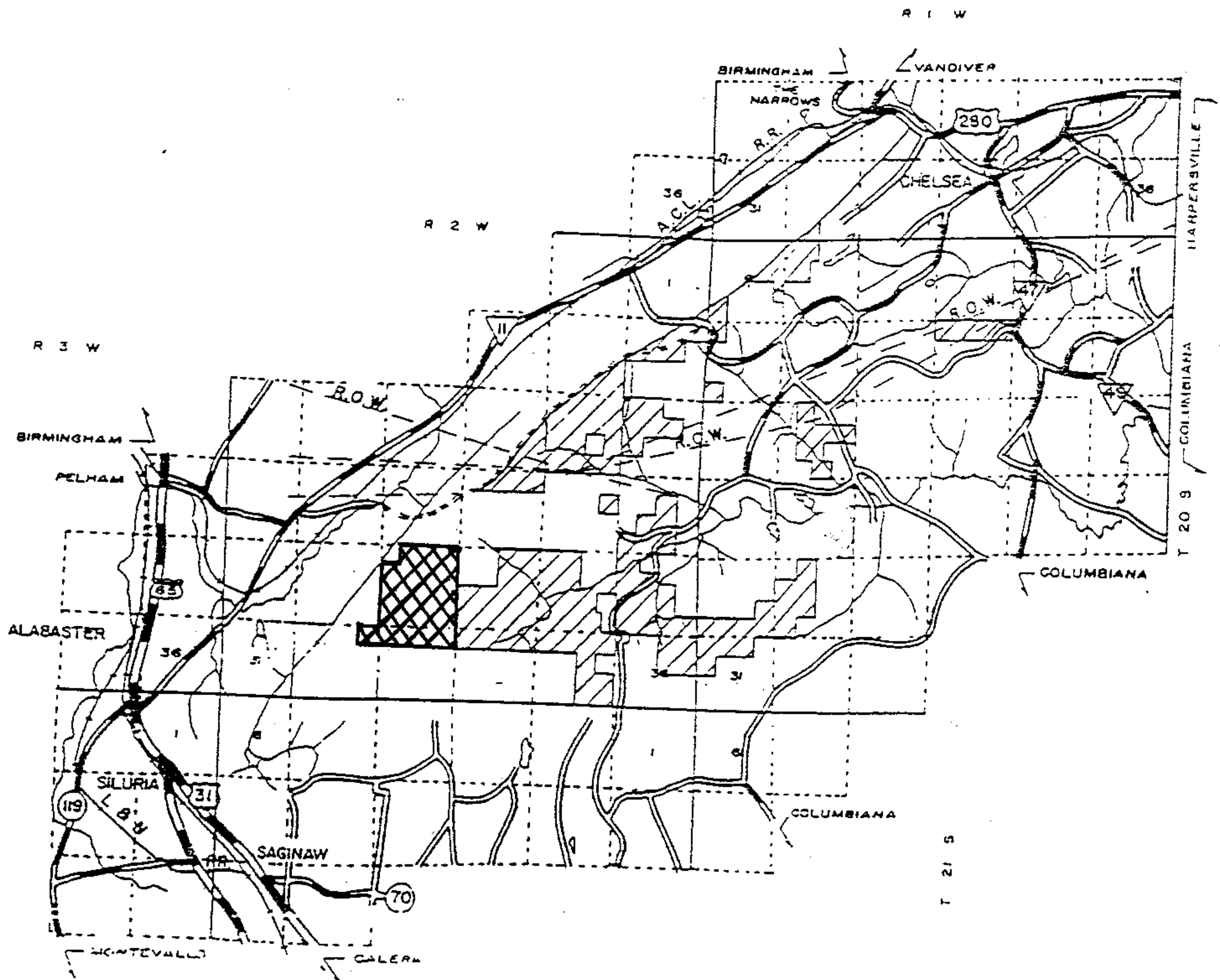
