THIS INDENTURE, made and entered into on this the 14<sup>TH</sup> day of December, 1993, by and between Kimberly-Clark Corporation, a corporation, hereinafter referred to as "Grantor" and Weatherly Investment Group, L.L.C., hereinafter referred to as "Grantee",

WITNESSETH

That for and in consideration of the payment of Six Hundred Fifty Thousand Dollars (\$650,000.00), by Grantee to Grantor, and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, Grantor does hereby grant, bargain, sell and convey unto the Grantee, the following described real estate:

(a) Section 28, except the northwest quarter of the northwest quarter, (b) the North 1/4 of Section 33, and (c) the northeast 1/4 of northeast 1/4 of Section 32; all located in Township 20 South, Range 2 West, Shelby County, Alabama.

SUBJECT, HOWEVER, to all easements, restrictions, rights-of-way for public roadways, public utilities and other easements heretofore filed for record which affect such property, mineral rights owned by others, and liens for all ad valorem taxes as may be assessed or become due after the date hereof (including such taxes due in 1993 and those assessed October 1, 1993 which are due October 1, 1994 and become delinquent if not paid before January 1, 1995, and including any tax based on changes in current use classification) all of which shall be paid by Grantee.

Together with all and singular the tenements, hereditaments, and appurtenances thereunto belonging or in anywise appertaining.

TO HAVE AND TO HOLD unto the Grantee, its successors and assigns in fee simple, forever.
