## ASSIGNMENT OF LIEN INTEREST IN MORTGAGES

WHEREAS, the Issuer assigned certain mortgages, together with & the debts thereby secured, the notes therein described, and all of the interests of the Issuer in and to the lands and property conveyed by said mortgages (such mortgages, debts, notes and interests together with the descriptions of the lands and property described in such mortgages, which such descriptions incorporated herein by reference, being hereinafter referred to as the "Collateral"), as collateral security to Southeast Bank, National Association, Trustee under the Indenture, pursuant to various assignments of mortgages, (said assignments of mortgages

WHEREAS, pursuant to the Indenture and that certain Assistance Agreement, dated as of September 19, 1991 ("Assistance Agreement"), among the FDIC, the Assignor, and First Union National Bank of Florida ("First Union"), First Union succeeded Southeast as the Trustee under the Indenture; and

WHEREAS, the parties hereto desire to give record notice of the transfer of the Assignor's interest in the Collateral to the Assignee and the succession of the Assignee to the trusteeship under the Indenture pursuant to the Indenture and the Assistance Agreement;

### WITNESSETH:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor as Trustee under the Indenture, does hereby grant, bargain, sell, convey, deliver, assign, transfer, and set over unto Assignee, its successors and assigns, all of the right, title and interest of Assignor as Trustee under the Indenture, in and to the Collateral, including, without limitation, the mortgages described on Exhibit B attached hereto and incorporated herein by reference (which exhibit sets forth the names of the mortgagors and the official record book and page numbers of the mortgages that have not been satisfied or otherwise cancelled of record and that were assigned by the Southeast Assignments), together with the debts thereby secured, the notes described therein, and all interests in and to the lands

and property conveyed by said mortgages, to be held by Assignee as the successor Trustee under the Indenture and in accordance with the same terms and conditions set forth in the Southeast Assignments.

TO HAVE AND TO HOLD the aforesaid property and all privileges and appurtenances thereto belonging to the Assignee in accordance with the terms of the Indenture.
