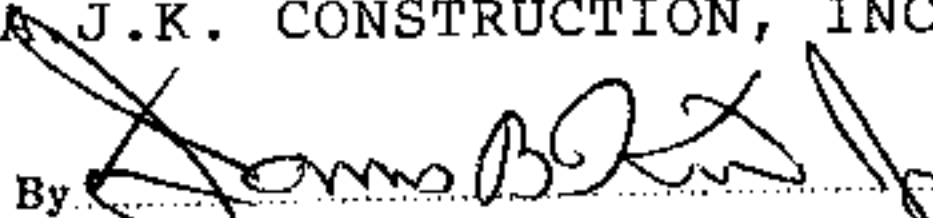
TO HAVE AND TO HOLD, To the said GRANTEEES for and during their joint lives and upon the death of either of
