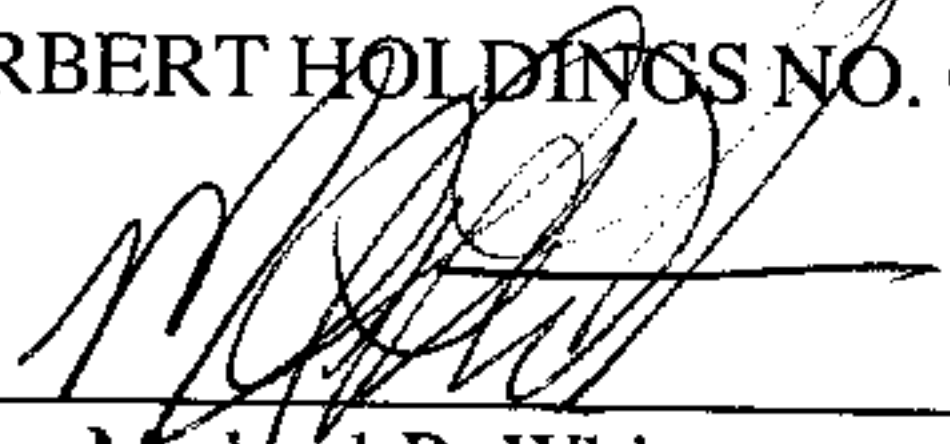
**CONSENT OF THE SOLE SHAREHOLDER TO DISSOLVE

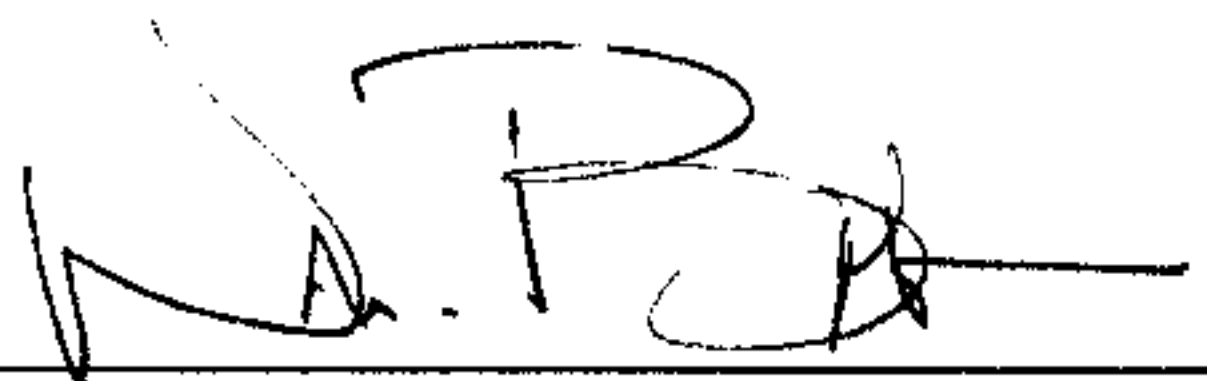

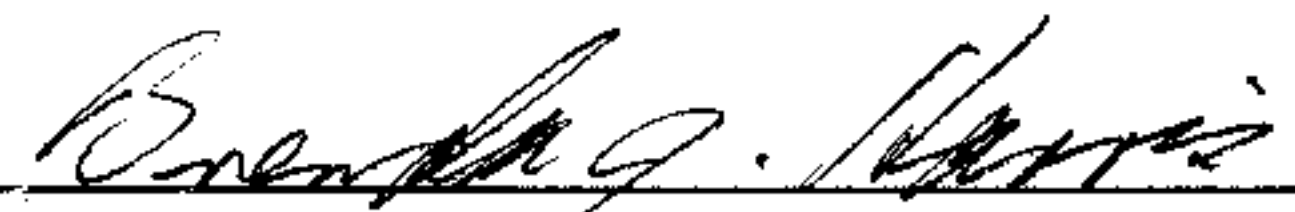
