SUMMARY JUDGMENT

This cause came on to be heard upon the "Motion For Summary Judgment" filed by Plaintiff on October 5, 1993, and after hearing statements and arguments of counsel, the Court finds that the following decretal orders are due to be entered.


It is, therefore, ORDERED, ADJUDGED and DECREED by the Court as follows:

ONE: The "Motion For Summary Judgment" is granted and SouthTrust Bank of Alabama, National Association, is entitled to the proceeds, both principle and interest, from the CD certificate number 9495 issued by Merchants & Planters Bank to Charles J. Gray and Carolyn Gray and Merchants & Planters Bank is directed to pay such proceeds to SouthTrust Bank of Alabama, National Association.

TWO: All remaining issues in this case are to be submitted to the Court within 30 days for hearing or they will be dismissed for want of prosecution.

THREE: Judgment is hereby rendered in favor of SouthTrust Bank of Alabama, National Association, and against Charles J. Gray on his guaranty in the amount of ONE HUNDRED FIVE THOUSAND SEVEN HUNDRED THIRTY THREE AND 52/100 DOLLARS (\$105,733.52) of which NINETY NINE THOUSAND THREE HUNDRED EIGHTY SIX AND 03/100 DOLLARS (\$99,386.03) is principle, FOUR THOUSAND THREE HUNDRED NINE AND 49/100 DOLLARS (\$4,309.49) is interest and TWO THOUSAND THIRTY EIGHT AND NO/100 DOLLARS (\$2,038.00) is attorneys' fees.
