That in consideration of Ten Dollars (\$10.00) and other good and valuable considerations in hand paid to the undersigned James H. Emack and wife, Henrietta S. Emack (hereinafter rererred to as "Grantors") by Anne Emack Couch and Susan Moyer Emack Alison (hereinafter referred to as "Grantees"), the receipt and sufficiency of which are hereby acknowledged, the said Grantors do, by these presents, grant, bargain, sell, and convey an undivided 1/30th interest unto Anne Emack Couch and an undivided 1/30th interest unto Susan Moyer Emack Alison in and to the following described real estate situated in Shelby County, Alabama, to-wit:

Lot No. 2 as shown on the Map of the Survey of Lake Wehapa which is recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Map Book 4, page 61.


