Begin at the N.E. corner of Section 4, Township 18 South, Range 1 East and run in a southerly direction along the Easterly line of said section a distance of 948.36 feet to a point on the northwesterly line of Shelby County No. 41, said point also being on a curve to the right having a radius of 2007.50 feet and a central angle of $8^{\circ} 23' 55''$; thence $53^{\circ} 04' 20''$ to the right (angle measured to tangent) in a Southwesterly direction along the northerly line of Shelby County No. 41 and along the arc of said curve a distance of 294.27 feet to a point, said point being the P.C.C.
