
WHEREAS, A MAJORITY OF VOTES CAST IN SAID ELECTION WERE IN FAVOR OF INCORPORATION; AND

WHEREAS, AN ENUMERATION OF THE INHABITANTS RESIDING WITHIN THE TERRITORY HAS BEEN COMPLETED AND RETURNED TO THIS COURT; AND

WHEREAS, ALL OF THE ABOVE HAVING BEEN REPRESENTED BY THE PETITIONERS TO COMPLY WITH SECTION 11-41 OF THE CODE OF ALABAMA (1975), AND THE COURT SO FINDING, BASED ON THE PLEADING AND PROOF HEREIN.

IT IS **ORDERED** AND DECREED THAT THE INHABITANTS OF THE TERRITORY WITH THE BOUNDARIES AS SHOWN BY THE PETITION FOR INCORPORATION, WHICH ARE ATTACHED HERETO AS EXHIBIT "A" AND MADE PART AND PARCEL AS FULLY AS IF SET OUT HERETO, ARE HEREBY INCORPORATED AS THE TOWN OF DUNNAVANT, AND THE TOWN IS HEREBY VESTED WITH ALL THE RIGHTS, POWERS AND AUTHORITY INCIDENT TO SUCH CORPORATIONS.

METES AND BOUNDS
DESCRIPTION**

All the certain portions of land platted or unplatted, within Sections 32, 33, & 34 of Township 17 South Range 1 East and Sections 3, 4, 5, 7, 8, 9, 10 & 18 of Township 18 South Range 1 East, Shelby County Alabama, DUNNAVANT, more fully described as follows:

Begin at the NW corner of Section 18, T18S R1E for the point of beginning. Go south along the west line of said section to the SW corner of the NW 1/4 of said section, turn east along the south line of said quarter section for a distance of 1320', turn south along the west boundary line of the NE 1/4 of the SW 1/4 for a distance of 1320' to the SW corner of said quarter quarter, turn NE and run along the diagonal 1/2 of said quarter quarter to the SW corner of the NE 1/4, turn east and run along the south boundary of said Quarter to the point of intersection with Wehapa Lake Circle, run NE along said street to the point of intersection with Kendrick Cemetery Road, run in a northly direction along said road to its point of intersection with County Road 41, run along County road 41 to its point of intersection with Wehapa Lake Drive, run east and north along Wehapa Lake Drive/Wehapa Lake Circle to its point of intersection with the east boundary line of Section 18, T18S R1E, run north along the east boundary line of Section 18 and Section 7 to the NE corner of the SE 1/4 of the SE 1/2 of Section 7, T18S R1E, run west along the north line of said quarter quarter to its point of intersection with County Road 41, run north along said road to its point of intersection with the north line of the SE 1/4 of Section 7, run east along said north boundary line to the SE corner of the SW 1/4 of the NW 1/4 of Section 8, T18S R1E, run north along the east line of said quarter quarter to the SW corner of the NE 1/4 of the NW 1/4, run east along the south line of said quarter quarter a distance of 3960' to the point of intersection with the east line of Section 8, run north along the east line of said section to the SW corner of Section 4, T18S R1E, run east along the south line of Section 4 a distance of 3960' to the NW corner of the NE 1/4 of the NE 1/4 of Section 9 T18S R1E, run south along the west line of said quarter quarter a distance of 1320' to its SW corner, run east along the south line of said quarter quarter a distance of 1980' to the mid-point of the south boundary line of the NE 1/4 of the NE 1/4 of Section 10, T18S, R1E, run north a distance of 1320' to the mid-point of the north boundary line of said quarter quarter, the west along the north boundary line of Section 10 to the SE corner of Section 4 T18S R1E, run in a northwesterly direction along the diagonal 1/2 of the SE 1/4 of said section to its point of intersection with Shoal Creek, run in a northeasterly direction along said creek to its point of intersection with the west line of Section 3 T18S R1E, run north along said west line to the SW corner of the N 1/2 of the NW 1/4, run east along the south line of the N 1/2 of said quarter a distance of 2640' to the east line of said quarter, run north along said east line 1320' to the point of intersection with the north line of Section 3, run west along said north line 2640' to the NW corner of said Section 3, run south along the west line of said section to its point of intersection with County Road 41, run in a southerly direction along said road to its point of intersection with the west line of the SE 1/4 of the NE 1/4 of Section 4 T18S R1E, run south along the west line of said quarter quarter to the NE corner of the NW 1/4 of the SE 1/4 of Section 4, run west along the

north line of said quarter quarter a distance 2640' to the SE corner of the SW 1/4 of the NW 1/4 of said section, run in a northerly direction along the east line of said quarter quarter a distance of 3960' to the SW corner of the NE 1/4 of the SW 1/4 of Section 33 T17S R1E, run east along the south line of said quarter quarter a distance of 1320', then north along the east line of said quarter quarter a distance of 1320' to the SW corner of the NE 1/4 of Section 33, run east along the south line of said quarter a distance of 1320' to the SE corner of the SW 1/4 of the NE 1/4 of Section 33, run north along the east line of said quarter quarter a distance of 1320' to the SW corner of the NE 1/4 of the NE 1/4 of Section 33, run east along the south line of said quarter quarter a distance of 2640' to the SE corner of the NW 1/4 of the NW 1/4 of Section 34 T17S R1E, run north along the east line of said quarter quarter to its point of intersection with the north line of Section 34, run west along the north line of Sections 34 & 33 a distance of 2640' to the NW corner of the NE 1/4 of the NE 1/4 of Section 33 T17S R1E, run south along the west line of said quarter quarter a distance of 1320' to the NE corner of the SW 1/4 of the NE 1/4 of said section, run west along the north line of said quarter quarter a distance of 1320' to its NW corner, run south along the west line a distance of 1320' to the NE corner of the SW 1/4 of Section 33, run along the north line of said quarter to its point of intersection with Central of Georgia railroad tracks, then run southwestly along said tracks to its point of intersection with the north boundary line of the SW 1/4 of the SW 1/4 of Section 33, T17S, R1E, run west along the north boundary line of said quarter quarter to the NE corner of the SE 1/4 of the SE 1/4 of Section 32, T17S, R1E, then south along the west line of said quarter quarter to its point of intersection with the north boundary line of Section 5 T18S R1E, run west along the north line of said section a distance of 1320' to the NW corner of the NE 1/4 of Section 5, then south along the west line of said quarter a distance of 1320' to the SW corner of the NW 1/4 of the NE 1/4 run east along the south line of said quarter quarter a distance of 1320' to the SE corner, then north along the east line of said quarter quarter to its point of intersection with the north boundary line of Section 5, T18S R1E, run east along the north line of said section a distance of 1320' to the NE corner of Section 5, then south along the east line of Section 5 a distance of 3960' to the NE corner of the SE 1/4 of the SE 1/4, then west along the north line of said quarter quarter a distance of 1320' then south along the west line of said quarter quarter to its point of intersection with the north boundary line of Section 8 T18S R1E, run west along the north line of said Section 8 a distance of 1320' to the NW corner of the NE 1/4 of Section 8, then south along the west line of said quarter to its point of intersection with County Road 41, run south along said road to its point of intersection with the east boundary line of the NW 1/4 of the NW 1/4 of Section 8, run along said east line to the SE corner of said quarter quarter, run west along the south boundary line of said quarter quarter to its point of intersection with County Road 41, run south along said road to its point of intersection with the east line of Section 7, T18S, R1E, run south along said east line to a point located 330' north of the SE corner of the NE 1/4 of said section, run west a distance of 1320' to the west line of the SE 1/4 of the NE 1/4 of Section 7, run south along said west line a distance of 1650' to the NE corner of the SE 1/4 of the SE 1/4 of Section 7, run west along the north line of said quarter quarter a distance of 1320', then south along the west line 660', run east a distance of 660', then south a distance of 660', then south a distance of 660' to the mid-point of the north line of the NW 1/4 of the NE 1/4 of Section 8, T18S, R1E, run west a distance of 660' to the NW corner of said

quarter quarter, the south along its west line a distance of 660', the west a distance of 1320' to the mid-point of the east line of the NW 1/4 of the NW 1/4 of Section 8, then north along said east line a distance of 660' to the point of intersection with the north line of Section 8, T18S, R1E, run west along said north line a distance of 1320' to the NW corner of Section 8 and the point of beginning.

Said territory contains 1,337.5 acres of land, more or less.
