(herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in

Shelby County, Alabama to-wit:

Commence at the NE corner of the SE 1/4 of the NE 1/4 of Section 7, Township 20 South, Range 2 West, and run North 89 degrees 07 minutes 20 seconds West a distance of 469.43 feet; thence South 50 degrees 17 minutes 59 seconds West a distance of 1119.34 feet to the Easterly right-of-way of Shelby County Highway No. 33 (80"R.O.W); thence South 16 degrees 11 minutes 48 seconds West a distance of 37.35 feet to the POINT OF BEGINNING of the parcel herein described, said point also being a point on a curve to the right having a radius of 262.00 feet and an arc length of 53.0 feet subtended by a chord which bears South 26 degrees 38 minutes 29 seconds West and run along the chord a distance of 52.91 feet; thence South 74 degrees 46 minutes 04 seconds East a distance of 24.58 feet; thence North 00 degrees 00 minutes 45 seconds East a distance of 53.75 feet to the point of beginning.
