- 2. That Petitioner is a bank established under the laws of the United States and as such is exempt from posting a bond under Section 40-22-2, Code of Alabama, 1975.
- 3. That the total amount of indebtedness which may be incurred under said Mortgage is \$3,500,000, of which \$3,500,000 is presently incurred, and that such indebtedness is secured by property located both within and without the State of Alabama.
- 4. That the value of the whole property securing such indebtedness both within and without the State of Alabama is \$17,950,000.
- 5. That the value of the property securing such indebtedness and located within the State of Alabama is \$3,200,000, or 17.8% of the total value of the whole property located both within the State, and that the property located in the State of Alabama is located in Shelby County.
- 6. That the amount of indebtedness allocable to Alabama and upon which tax is to be paid is an amount equal to 17.8% of the total indebtedness1994002473me to time incurred under and secured by said MorangageRTIFIED

- 7. That the amount of the indebtedness presently incurred allocable to the State of Alabama and upon which the recording privilege tax is now due is \$623,000.
- 8. That the recording privilege tax to be paid at the rate of \$.15 per \$100 or fraction thereof is \$934.50.

IT IS, THEREFORE, ORDERED that the Judge of Probate of Shelby County, Alabama, wherein the Mortgage will be recorded, shall collect mortgage privilege tax in the amount of \$934.50, plus any recording fees which may be due.
