in the Record of Mortgages on file in your office to secure an indebtedness owed the Beneficiary; and,

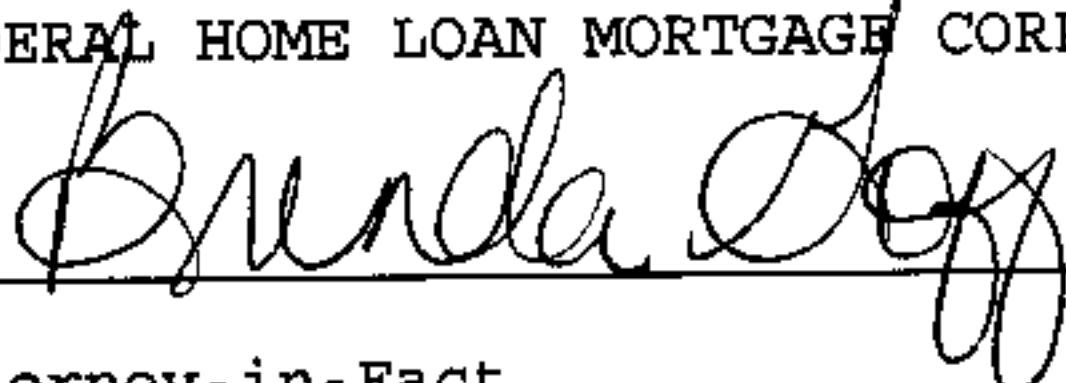
Whereas, the Mortgage was assigned to FEDERAL HOME LOAN MORTGAGE CORPORATION
