AMENDMENT TO ACCOMMODATION MORTGAGE AND SECURITY AGREEMENT (CONSTRUCTION - ALABAMA)

Each representation and warranty contained in the Mortgage is hereby reaffirmed as of the date hereof, and the Accommodation Mortgagor hereby makes each representation and warranty contained in the Mortgage as to the real and personal property granted and conveyed to the Bank hereby as fully as if the real property described on Addendum 1 hereto were described on Exhibit A to the Mortgage upon its original recording.
- 4. Effective Date. The effective date of this Amendment is the date first set forth above.
- 5. Effect of Amendment. Except as specifically modified herein, all provisions of the Mortgage shall remain in full force and effect.
