- g) To purchase, acquire, hold, improve, sell, convey, assign, exchange, mortgage, encumber, lease, hire, and deal in real and personal property of every kind and character.
- h) To purchase, acquire, hold, subdivide, develop, and operate real estate to erect buildings thereon, and to sell, lease, maintain, own, repair and operate such properties.
- i) To borrow and lend money and to give or take security therefor by way of mortgage, pledge, transfer or assignment of real or personal property of every nature and description.
- j) To purchase or otherwise acquire its own shares of stock (so far as may be permitted by law) and its bonds, debentures, notes, or evidence of indebtedness, and to hold, sell, transfer or reissue the same.
