The undersigned acting as incorporator of a corporation under the Alabama Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST:

The name of the proposed corporation shall be: FALLICO, INC.

SECOND:

The period of its duration shall be perpetual.

THIRD:

The purposes for which this corporation is organized are:

To carry on the business of real estate developers and for that purpose to purchase, sell and generally to deal in land; individual lots, acreage, subdivisions and all other types and kinds of land, both improved and unimproved, of every name and

nature, and to do or cause to be done all other things required or incidental to the carrying out the above objects or any of them.
