
ALABAMA RELEASE OF MORIGAGE



WHEREAS, pursuant to Order No. 92-455 dated october 16, 1992, the Director of the Office of Thrift Supervision under duly delegated authority appointed the Resolution Trust Corporation as Receiver of Security Savings & Loan Association; and

WHEREAS, pursuant to Order No. 92-455 dated October 16, 1992, Security Federal Savings & Loan Association was duly formed as a federally chartered savings association by the Director of the Office of Thrift Supervision under duly delegated authority; and

WHEREAS, on or about October 16, 1992, a Purchase and Assumption Agreement was made and entered into by and between Resolution Trust Corporation as Receiver of Security Savings & Loan Association and Security Federal Savings & Loan Association purchased from Resolution Trust Corporation as Receiver of Security Savings & Loan Association all of the right, title and interest in and to substantially all the assets of Security Savings & Loan Association that it then owned or held; and

WHEREAS, pursuant to Order No. 92-455 dated October 16, 1992, the Director of the Office of Thrift Supervision under duly delegated authority appointed the Resolution Trust Corporation as Conservator of Security Federal Savings & Loan Association; and

WHEREAS, on NOVEMBER 10, 1989 , TIMOTHY J. MACHAN AND WIFE FLIZABETH MACHAN executed a mortgage to the FIRST COMPRICAL MORICAGE CORPORATION on certain real estate located in SHFIBY County, Alabama, which property is fully described in said mortgage, and which mortgage is recorded in Volume 266 at Page 708 , of the records in the Office of the Judge of Probate of SHFIBY County, Alabama; and

WHEREAS, any assignments of said mortgage are listed as follows:
