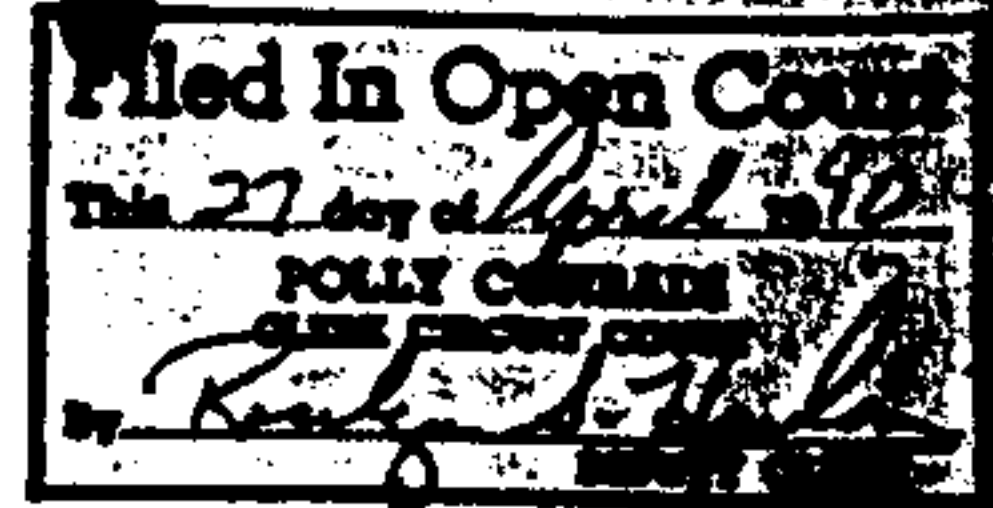

ORDER ON MOTION FOR SUMMARY JUDGMENT FILED BY THE PLAINTIFF,
CLARK & SCOTT, P.C.

The Motion for Summary Judgment filed by the plaintiff, Clark & Scott, P.C., was assigned to the undersigned to be heard by the Presiding Judge, after this motion had been announced ready on the regular motion docket before the Presiding Judge on April 26, 1990. Said Motion was heard by me on April 26, 1990 and was taken under advisement.

This Motion is submitted upon the Affidavit of G. Steven Henry, which is attached thereto.

The defendant is present in Open Court, and states that he mailed an Affidavit to the Clerk of this Court which, after a check by personnel in the office of the undersigned, has not been filed, and neither does same appear on the Case Action Summary Sheet as having been received by the Clerk of this Court.

As a matter of fact, the Clerk of the Court can find no record of any affidavit from the defendant in opposition to this Motion for Summary Judgment.

The parties have previously announced ready, and the Court has also reviewed an unsigned copy of what the defendant says is a copy of his alleged affidavit which he allegedly mailed to the Clerk of Court. The Court, even if said Affidavit had been filed, does not find same to be sufficient in content or form.

Therefore, the Court grants the Motion for Summary Judgment filed by the plaintiff, Clark & Scott, P.C., and JUDGMENT be and the same is hereby entered in favor of the plaintiff and against the defendant for the sum of SEVEN HUNDRED AND NO/100 (\$700.00) DOLLARS.

All costs of court are hereby taxed to the defendant.
