ASSIGNMENT OF MORTGAGE

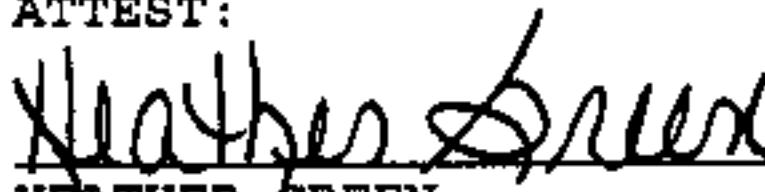

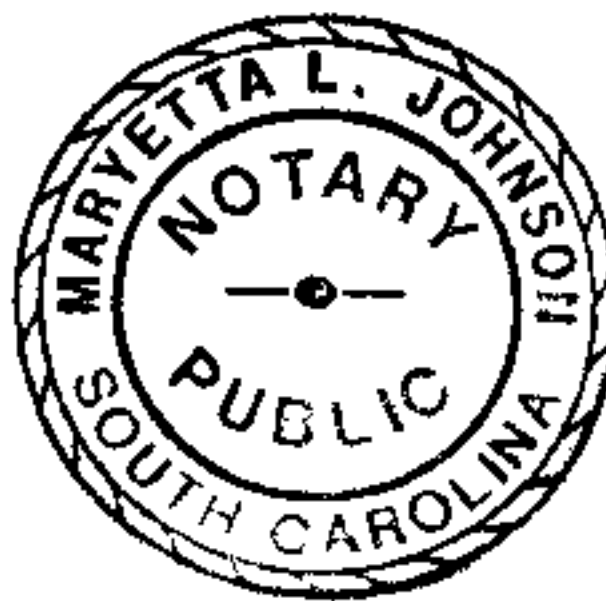
