ASSIGNMENT OF MORTGAGE AND NOTE

THIS ASSIGNMENT OF MORTGAGE AND NOTE is made and entered into to be effective as of _____1991 by and between Old Stone Corporation, a corporation organized and the 15th day of Oct. existing under the laws of the State of Rhode Island ("Assignor") and Resolution Trust Corporation ("RTC"), with offices at 150 South Main Street, Providence, RI 02903, acting in its capacity as Conservator of Old Stone Federal Savings Bank ("Assignee").

WHEREAS the Office of Thrift Supervision ("OTS"), Department of the Treasury of the United States, by Order No. 93-12 dated January 29, 1993, a copy of which is attached hereto as Exhibit B appointed RTC as Receiver for Old Stone Bank, a Federal Savings Bank ("Old Stone"). On January 29, 1993 RTC accepted such appointment and, by operation of law, thereupon succeeded to "all rights, titles, powers, and privileges" of Old Stone pursuant to 12 U.S.C. Section 1821(d)(2)(A). The RTC, as Receiver for Old Stone, immediately organized Old Stone Federal Savings Bank ("New Stone") and caused it to be chartered as a federal savings association.

WHEREAS on January 29, 1993, RTC as Receiver for Old Stone entered into a Purchase and Assumption Agreement with RTC as Conservator for New Stone which provided, inter alia, that the right, title, and interest in and to substantially all of Old Stone's assets, including real property, mortgages, deeds of trust and similar security instruments, and other loans, be transferred to New Stone. As Receiver for Old Stone, RTC was authorized and empowered to transfer any asset of Old Stone "without any approval, assignment or consent with respect to such transfer," pursuant to 12 U.S.C. Section 1821(d)(2)(G).

WHEREAS the OTS, by Order No. 93-12 dated January 29, 1993 a copy of which is attached hereto as Exhibit C, appointed RTC as Conservator for New Stone. On January 29, 1993, RTC accepted such appointment.

WHEREAS by virtue of the foregoing, RTC as Conservator for New Stone is authorized and empowered to sell, assign, transfer, convey, deliver, release, satisfy, discharge, modify, amend or otherwise deal with all or any portion of this right, title and interest in and to any asset acquired from Old Stone, including mortgages, deeds of trust and other evidences of security interests, and other loans, real and personal property.

NOW THEREFORE, for value received, Assignor hereby remises, releases, quitclaims, transfers, assigns, and delivers to Assignee, its successors and assigns, any and all of Assignor's right, title and interest in and to _____, State of <u>Ala.</u> the Mortgage(s) located in the County of ____Shelby listed in Exhibit "A" attached hereto and made a part hereof. TOGETHER WITH the Note(s) collateralized by said Mortgage(s), the monies due or to become due thereon, with interest, and all rights accrued or to accrue under said Mortgage(s) and Note(s).
