A PARCEL OF LAND SITUATED IN THE NE 1/4 OF THE NE 1/4 OF SECTION 30, TOWNSHIP 19 SOUTH, RANGE 1 EAST, HUNTSVILLE PRINCIPAL MERIDIAN, SHELBY COUNTY, ALABAMA AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER OF SAID SECTION 30, TOWNSHIP 19 SOUTH, RANGE 1 EAST, THENCE WESTERLY ALONG AND WITH THE NORTH LINE OF THE SECTION 665.37 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE WESTERLY ALONG AND WITH SAID NORTH SECTION LINE 332.69 FEET TO A POINT; THENCE TURN 90 DEGREES 22 MINUTES 24 SECONDS LEFT AND RUN SOUTHERLY 1259.28 FEET TO THE NORTHERLY RIGHT OF WAY OF COUNTY HIGHWAY NO. 280 (OLD HIGHWAY 280 OR FLORIDA SHORT ROUTE), SAID RIGHT-OF-WAY LYING 40 FEET DISTANT FROM CENTERLINE; THENCE TURN A RIGHT INTERIOR ANGLE OF 70 DEGREES 41 MINUTES 36 SECONDS TO CHORD AND RUN NORTHEASTERLY IN A CURVE TO THE LEFT ALONG AND WITH SAID RIGHT-OF-WAY LINE, HAVING A RADIUS OF 1869.86 FEET, A CENTRAL ANGLE OF 9 DEGREES 58 MINUTES 58 SECONDS AND AN ARC LENGTH OF 325.79 FEET TO A POINT; THENCE TURN A RIGHT INTERIOR ANGLE OF 109 DEGREES 19 MINUTES 25 SECONDS FROM CHORD, LEAVING SAID HIGHWAY RIGHT-OF-WAY LINE, AND RUN NORTHERLY 350 FEET TO A POINT, THENCE TURN A RIGHT INTERIOR ANGLE OF 245 DEGREES 15 MINUTES 32 SECONDS AND RUN NORTHEASTERLY 27.81 FEET TO A POINT; THENCE TURN A RIGHT INTERIOR ANGLE OF 114 DEGREES 44 MINUTES 28 SECONDS AND RUN NORTHERLY 787.91 TO THE POINT OF BEGINNING, MAKING A CLOSING INTERIOR ANGLE OF 90 DEGREES 21 MINUTES 23 SECONDS.
